1. Apologies and Declarations of Interest: Apologies had been received from Cllr Carrington, Cllr Griffin and County Cllr Cawrey. There were no Declarations of Interest.

Police Report: A report had been received stating that during the period 17th September 2018 to 15th October 2018 there had been no recorded crime.

- **5a. Highways Issues:** Following our request to resurface the missed area on Hall Drive a response had been received from Highways informing that the surface dressing works had been completed and demobilised for this year and it will be completed Summer 2019. To be monitored.

- The NKDC Community Champions Annual Awards ceremony had recently been held at the International Bomber Command Centre.
- A memorial service for the late Cllr Marion Brighton MBE was due to be held at Lincoln Cathedral on 9th November at 2pm. All welcome.
- The controversial LCC contract with Serco has been renewed until 2020 with a few specific functions including payroll to be brought back in-house within the Council.
- 'Fix My Street' the Council's new official highways reporting system went live in September.
- The North Hykeham relief road western corridor had now been agreed at a cost of 148.5 million pounds for a dual carriageway. A single carriageway would incur costs of between 100 and 117 million pounds.
- The summer Surface Dressing programme had now been completed.
- Dixon Street has been re-opened after a twelve week closure.
- A campaign is to be held for cleaner recycling. It was noted 25% of items sent for recycling fail because of contamination.
- Roadworks are to be undertaken under Potterhanworth Bridge shortly.
- Stronger economic links with Hunan Province had been forged.
